OLD BUSINESS

Transfer of ownership of 34.275 acres identified as the Grayson County Industrial Park Property; Tax Map #73-A-113A from the Grayson County Board of Supervisors to the Grayson County Economic Development Authority for the purpose of facilitating economic development.

Secretary Jonathan D. Sweet noted that the appraisal has been completed – 33.666 acres at \$250,000. Robert E. Williams made the motion to accept; duly seconded by Gregory M. Webb. Motion carried 4-0.

NEW BUSINESS

Partial Reduction in Obligation Agreement – Core Health & Fitness, LLC.

Secretary Jonathan D. Sweet explained the partial reduction in obligation agreement explaining that the IDA (Industrial Development Authority) needs to ratify the agreement. Joseph M. Killon made the motion to approve; duly seconded by Robert E. Williams. Motion carried 3-0 with Gregory M. Webb abstaining.

PARTIAL REDUCTION IN OBLIGATIONS AGREEMENT

This Agreement is dated as of the 31st day of December, 2014 by and between the Economic Development Authority of Grayson County, Virginia (formerly known as the "Industrial Development Authority of Grayson County, Virginia and hereinafter referred to as **the "Authority"**) and Core Health & Fitness, LLC ("Core Health");

Core Health had previously assumed certain obligations of Med-Fit Systems, Inc. ("Med-Fit"), including that certain promissory note of Med-Fit, dated as of May 1, 2013 in the original principal amount of \$225,613 (the "Assumed Obligation").

For valuable consideration deemed paid by the parties, the parties hereby agree that the Assumed Obligation is reduced by the amount of the Local Vendors Payment (\$40,111.31).
