- Angela Briam - Sip \& Taste - Ms. Briam and the members discussed her startup requests - Ms. Hash made the motion to grant \$30K grant to purchase new equipment or reimburse Sip \& Taste for equipment already purchased if terms are approved by the County Attorney; duly seconded by Ms. Jackson-Ricketts. Motion carried. Ms. Hash made a motion to approve a loan of \$20K for operating costs 18 months with the first 6 months interest only, then amortized for the next 12 months at $5 \%$ interest and to be secured with equipment/furniture/fixtures/inventory if the terms are approved by the County Attorney/Administration; duly seconded by Mr. Baumgardner. Motion carried.
